Sub: Prevention & Prohibition of Ragging in Technical Institutions, Universities, etc.

Dear Sir,

You are aware that Ragging in Institution has become a menace to the society, which causes severe physical and mental agony to the freshers as well as the existing students and it is our responsibility to prevent and eliminate the Ragging in the institutions,

In view of the directions of the Hon'ble Supreme Court in SLP No. 24295 of 2006 dated 16.05.2007 and Civil Appeal number 887 of 2009, dated 08.05.2009 (Copy of the judgement of the Hon'ble Supreme Court of the India is available on [www.court.nic.in/court.nic.sc.asp](http://www.court.nic.in/court.nic.sc.asp)) various measures to combat this unsocial behaviour and to get rid of the ill effects of ragging amongst the students, have been suggested by the two Regulatory Bodies of Higher Education i.e. University Grants Commission and All India Council for Technical Education vide their following Notifications :

1. University Grants Commission - 'Regulations on curbing the menace of ragging in Higher Educational Institutions, 2009' under No. F.1-16/2007(CPP-II) dated 17<sup>th</sup> June, 2009.
2. All India Council for Technical Education - Notification No. F.No.37-3/Legal/AICTE/2009 dated 01.07.2009 on 'Prevention and prohibition of Ragging in Technical Institutions, Universities including Deemed to be Universities imparting technical education'.

Therefore, this is to remind you that the measures and actions to be taken against ragging as recommended vide the above two Notifications may kindly be followed strictly. Kindly inform this office your action in the matter for prevention of ragging in your institution in order to ensure a healthy environment for the students.


In this context, I am directed to request you to kindly install the CCTV in the vulnerable places of your college including hostels. Moreover, strict vigilance in the hostel round the clock is to be given the utmost importance.

We hope you will take action accordingly.
